


**GREENE TOWNSHIP BOARD OF SUPERVISORS  
MINUTES OF WORKSESSION  
FEBRUARY 8, 2016**

In attendance were Supervisors Richard F. Allgeier, Jr., Linda M. Bliley and Lisa A. Vallimont. Work session commenced @ 3:30PM. Topics of discussion were as follows:


1. Discussion was held regarding the Papesch property on Lake Pleasant Road as a site for a pump station for the proposed sewer system.
2. Property appraisals for pump station sites were reviewed.
3. Discussion was held regarding re-hiring Timothy Eliason as a garage employee.
4. L. Vallimont will complete an Erie Co. Greenways Grant application on behalf of the township. The funds will be requested for the playground.
5. L. Vallimont stated that N. Zimmer would be doing the utility billing. L. Bliley stated that she would be interested in taking over the billing and will follow through with enforcement too.
6. L. Vallimont stated that Jim Kennerknecht called to request a meeting of the auditor's be advertised for February 10 @ 7:00 pm.
7. R. Allgeier provided an update on the recycle truck, trailblazer and #26.
8. L. Bliley inquired about a workman's comp claim from Linda Cagnoli that is still being paid. L. Vallimont stated that the insurance company is paying for TENS supplies, approximately \$45/month.
9. R. Allgeier inquired as to whether or not we will need to request a refund from North East Township for the amount that we paid into the recycle truck. L. Vallimont will look into this.




